Sealed proposals are hereby solicited by the Quonset Development Corporation (QDC) to procure a prime contractor to staff and supervise port security guards who conduct access control into the Port of Davisville and at Pier One and at Pier Two. The Port of Davisville is a federally regulated facility and is subject to the Maritime Transportation Security Act (MSTA), 33 CFR Part 105.

Interested firms are required to submit proposals which clearly indicate the extent to which all requirements of the Request for Proposal will be fulfilled, including but not necessarily limited to staff experience, recent project experience, and the firm's role relative to the various project requirements. Each proposal must include at a minimum the following:

- Narrative description of the project scope of work which substantiates the firm's understanding of the project objectives;
- Technical information describing background, qualification, and experience with and for similar programs, as well as the work plan or approach proposed for this requirement. Firm/Team information and related project experience.
- A detailed description and cost of each task of the Scope of Services to be undertaken that indicates how the project would be completed, including a breakdown of any components; hours; resumes; billing rates and fees.
- A timeline for completion and contract costs of the components described above.
- Anticipated hours to staff the access control point are approximately 5,000 hours annually.
