CONTRACT SUMMARY

The Division of Purchases established a contract (in conjunction with the Western States Contracting Alliance/WSCA), starting May 1, 2011 through February 28, 2014. The available 3-year option to renew was exercised; the new contract expiration date is February 28, 2017. Facilities maintenance, lighting products, industrial supplies and tools are available under this MPA. Some of the specific items included are: HVAC, air filters, lamps, ballasts, fixtures, cleaning supplies, material handling repairs, security, motors and accessories, electrical repairs and equipment, fasteners, batteries and flashlights, outdoor garden supplies and equipment, paints and accessories, plumbing, pneumatic tools, power tools and accessories, safety, hand tools and welding and soldering. Thousands of items can not only be found in vendor supplied catalogs but also on the individual vendor's website.
