STATE CLEAN DIESEL GRANT PROGRAM

IT IS THE INTENT THE INTENT OF DEM TO ACCOMPLISH THE FEDERALLY REQUIRED POLLUTION CONTROL UPGRADES USING SEVERAL FORMATS ON SPECIFIED VEHICLES (STATE AND, MUNICIPAL SCHOOL BUSES)

1. DEM directs the vendors to perform work on specific diesel vehicles (state, municipal, school buses) and pays the vendors directly for the work performed via signed grant agreements
2. DEM directs the vendors to perform work on specific diesel vehicles (state, municipal, school buses) and the entity having the work performed (city/town or another state agency) pays the vendors for the work performed and we, DEM, reimburse them for the costs incurred via signed grant agreements .
3. A city/town, another state agency or quasi-state agency (RIAC or RIRRC) chooses a vendor and directs them to perform work and pays the vendor for the work performed with no reimbursement from DEM. Entities wishing to participate in this program will be required to contact DEM prior to utilizing these agreements

Agencies will need to contact DEM for DEM to obtain a quote for actual installation of emission control devices. Prices submitted by vendors for this RFP were for equipment only. Installation prices will vary depending on the model and year of the particular vehicle being retrofitted.

Pricing reflected in the attached price list represents maximum allowed: entities are encouraged to negotiate with MPA 449 vendors

Instructions to Bidders:

In order to compare the pricing offered by Bidders, Bidders are requested to provide information on the costs associated with retrofitting diesel school buses and state and municipal diesel vehicles. In order to qualify for a contract award, Bidders are required to comply with the following terms in completing this form and return it with their Response:

- Bidders must provide unit prices for at least one product and installation service for any of the Control Level 1 -3 equipment and at least one product and installation service for Closed Crankcase Ventilation filter based on a purchase of one to ten retrofits. Bidders should be as accurate as possible in the price they offer; this information will be used to evaluate pricing for the RFP.
- For purchases greater than 10 units, Bidders have an opportunity to offer an additional discount for the various volume bands indicated. This information will also be used to evaluate pricing for the RFP.
- Delivery must be included in all of the pricing (per section 7 of the RFP).
- All other pricing (other than diesel school buses) will be negotiated between the customer and the Contractor at the time of purchase. Such pricing should be in line with the general estimates provided in this RFP.
- Proposals must be presented in the format requested in this RFP. All questions should be answered and all instructions adhered to. Deviations from these instructions must be identified and are submitted at the risk of the proposal being ruled invalid.
