**1. CLASSIFICATION AND SCOPE:**

**1.1** This specification covers Men's Golf Style Shirts in (2) fabrics and sleeve lengths as described herein.

**1.2 Material: Two Types**

- A. 100% Cotton, preshrunk, colorfast, long sleeve**
- B. 50% Cotton/50% Polyester Permanent Press**

**1.3 Color:** Solids as specified by agency.

**1.4 Sizes: Men's**

**2. APPLICABLE SPECIFICATION:** There are no other specifications applicable to this specification.

**3. REQUIREMENTS:**

**3.1 Style:** Pullover style. Rib knit collar, two button placket, tape around collarete covering seam. Short sleeve shall be a 1" rib knit cuff on the sleeve. Long sleeve shall have a rib knit cuff approximately 2" in width). Shirts shall have a 2" double needle hemmed bottom.

- Two Styles:**
- a. Long Sleeve**
  - b. Short Sleeve**

**3.2 Label:** Shirts shall have a permanent brand and size label.

**3.3 Fiber Content:** Shirts shall be labeled as to the fiber content in accordance with Federal Trade Commissions, "Textile Fiber Products Identification Act."

**3.4 Workmanship:** Shirts shall be First Class and Manufactured in accordance with good commercial practices and shall be cleanly finished and well made with no defective stitching, raw edges or loose threads.

**4. SAMPLING AND INSPECTION:**

**4.1 Inspection:** Shirts will be inspected at point of delivery. The State reserves the right to reject upon inspection.

**5. PREPARATION FOR DELIVERY:**

**5.1 Packaging:** Unless otherwise specified, commercial packages will be acceptable under this specification.

**5.2 Marking:** Unless otherwise specified, all packages must be marked on the side with the name of the commodity, size, color and count.

**6. BID SAMPLES:** Buyer, subsequent to bid opening, may instruct (3) lowest bidders to submit samples. Samples shall not be submitted with bid.
