- 1 ALL PERMITS REQUIRED FROM LOCAL AND / OR STATE AGENCIES
- 2 COORDINATING A PRE-CONSTRUCTION MEETING WITH THE ENGINEER AND STATE CONTACT PERSON
- 3 ALL WORK WILL CONFORM TO THE RULE AND REGULATIONS OF THE LOCAL AUTHORITY AND THE RI DEPARTMENT OF ENVIRONMENTAL MANAGEMENT
- 4 THE CONTRACTOR MUST SUBMIT INSTALLER'S LICENSES' (AS ISSUED BY THE RIDEM) AND, IF REQUIRED, BE ON THE APPROVED LIST OF THE LOCAL AUTHORITY, WITH THE BID
