**SCOPE OF WORK:**

The Rhode Island Department of Transportation Division of Highway & Bridge Maintenance currently owns and operates a Maintenance garage at its Northwest Maintenance District Facility located on 38 Spring Brook Road in Scituate, Rhode Island. The facility includes personnel offices, equipment, salt dome, storage area, a garage, a repair yard, gas pump station, and surface parking.

**SPECIFICATIONS:** DESCRIPTION OF WORK (OUTLINED AS FOLLOWS)

**JOB ORGANIZATION:**

- 1 Schedule and coordinate work
- 2 The Contractor shall be responsible for any Federal, State or local permits which are required
- 3 Requirements of the job shall be reviewed with the Site Superintendent prior to beginning work
- 4 The Contractor shall provide all labor, materials, equipments, permits, drawings (if needed) and the services for the proper completion of this project
- 5 The Contractor shall be responsible for the removal and disposal of all debris from the job site

Listed below is scope of work for the above project. The renovations at this facility will focus on the Main building.

**1- MAIN BUILDING:**

**FRONT:**

- Furnish and install two (2) new steel entrance doors to include: pressure treated framing material, kiln dried wood jambs, doors, hinges, panic hardware, locksets and door closers as per the walk thru with the Facility Manager
- Remove and dispose two (2) single pane windows and replace with new thermal pane construction windows
- Furnish and install pressure treated framing material and trim out with PVC flat stock

- New header to be closed in with framing material and PVC trim stock

REAR:

- Remove and Dispose sixteen (16) single pane windows and frames and replace with new thermal pane vinyl construction windows
- Furnish and install pressure treated framing material and trim out with PVC flat stock, as per the walk thru with the Facility Manager
- New header to be closed in with framing material and PVC trim stock

RIGHT SIDE GABLE:

- Remove and dispose four (4) single pane windows and frames and replace with thermal pane vinyl construction windows
- Furnish and install pressure treated framing material and trim out with PVC flat stock, as per the walk thru with the Facility Manager
- Furnish and install pressure treated framing material and trim out with PVC flat stock as per the walk thru with the Facility Manager
- New header to be closed in with framing material and PVC trim stock

OTHER:

- Remove and dispose office foyer wooden door and frame
- Supply and install pressure treated framing material and trim out with PVC flat stock
- Furnish and install one (1) new steel entrance door with wood jamb, panic hardware, lockset and door closer

**STORAGE OF CONSTRUCTION MATERIALS AND/OR EQUIPMENT:**

The Contractor shall be permitted to utilize a portion of the Scituate Maintenance District Facility property for overnight storage of construction materials/equipment The Contractor shall be solely responsible for securely storing all materials/equipment and shall hold the State of Rhode Island harmless for any loss and/or damages incurred
