SCOPE OF WORK: CONTRACTOR SHALL SUPPLY AND INSTALL A PAIR OF (2) NEW TWENTY FIVE FOOT (25) STEEL INTERNAL HALYARD FLAGPOLES AT THE FOLLOWING LOCATION: UPPER COLLEGE ROAD OPPOSITE THE WELCOME CENTER
SEE PLAN FOR LOCATIONS

FLAGPOLE: SHALL BE TWENTY FIVE FEET (25') HIGH, MEASURING FROM THE GROUND TO THE TOP THE POLES SHALL BE COMMERCIAL GRADE HOT DIPPED GALVANIZED (BLACK SATIN FINISH) MEETING THE FOLLOWING SPECIFICATIONS:

- EXPOSED LENGTH: 25 FEET
- OVERALL LENGTH: 28 FEET
- BUTT DIAMETER: 10 INCHES
- TOP DIAMETER: 5 INCHES
- BASE WALL THICKNESS: 500 INCHES
- BASE PLATE: 12" x 12" x 1" STEEL BOLT THROUGH PLATE
