

The State of Rhode Island on behalf of William M. Davies Jr. Career & Technical High School is hereby soliciting bids for the replacement of a 1200 gallon domestic hot water tank in the mechanical room:

1. Isolate and drain down tank and remove insulation.
2. Disconnect all gas, electrical, piping and flue from RayPak hot water boiler.
3. Move RayPak boiler out of the way for rigging of the DHW tank.
4. Rig old DHW tank out and dispose of offsite.
5. Rig new tank into place and set on existing pad.
6. Reconnect all piping and pumps to new tank.
7. Tank and piping to be insulated in place.
8. New tank is to be epoxy lined.
9. Set RayPak hot water boiler on existing pad and reconnect all gas, electrical piping and flue.
10. Refill tank, startup Raypak boiler and test for leaks.
11. All work to be performed during normal working hour (6:00am to 4:30pm)
12. Contractor to verify all tank dimensions, all piping sizes, all fittings
13. New tank is to comply with all State, and Federal drinking water rules and regulations.
14. All work to include a one (1) year warranty and a manufactures warranty on the new DHW tank.
15. Contractors are to have all required State Licenses to perform this type of work.
16. Contractor is to supply all permits required for this type of work
