

1). QUESTION: Is there a list to identify all Smoke Detectors, Pull Stations, Heat Detectors, Damp & Flow Switch? Can this information be provided?

ANSWER: There are approximately 47 pull stations and approximately 18 tamper devices.

As far as the heat detectors go that is not an answer available. Thought there might be combination devices in the elevator shafts.

All in all there are approx. 200 smoke detectors that we were given as a count the last time this went out to bid.

2). QUESTION: Is it required to tag each zone, every valve, & sectional etc.?

ANSWER: Agency has suggested that vendor contact and comply with local jurisdiction Fire Marshall.
