





The Rhode Island Department of Administration's Division of Purchases, on behalf of the Department of Transportation (RIDOT) Maintenance Division, is soliciting bids from qualified firms to provide preventative maintenance, diagnostic and repair services for the current fleet of twenty (20) Elgin Pelican Sweepers and one (1) Mack Vactor Truck.

**Contract Period:**

Contracts will be effective from 10/1/12 to 6/30/14 and may be subject to two additional one year extensions, at the State's option, based on a determination of continued needs for these goods and services, acceptable performance by participating vendors and availability of funds.

**Bid Requirements:**

Offerers may submit any information describing their ability to provide the services requested, but **MUST** complete and return the enclosed "BID SUMMARY" and all related sections of the "BID RESPONSE: COST PROPOSAL" in order to be considered. Failure to provide all required information or to provide all required signatures by an officer or authorized agent of the offerer may result in rejection of the offer in its entirety.

**Evaluation of Offers:**

The evaluation of offers will be based on a comparative determination of the extent to which each offerer's submission meets the requirements and price (Summary and Cost Proposal).

**B. Diagnostic and Repair Services: Conditions and Restrictions**

- ❖ In general, for diagnostic and repair services for sweepers, pick up and delivery to and from the vendor's facility will be arranged by the State. The State, when unable to supply sufficient manpower to arrange pick up and delivery, will require vendor supplied pick up and delivery services. During the vendor supplied pick up and delivery, the vendor will be solely responsible for all liabilities, including bodily injury and property damage.
- ❖ All work is to be conducted at State facilities unless directed otherwise. NO subcontracting is acceptable. Should extraordinary circumstances warrant the acceptance of subcontracted services, a written request fully disclosing these circumstances is to be forwarded to the Division of Purchases and Assistant Director of DOT Maintenance Division for written disposition prior to the initiation of any subcontracted work.
- ❖ Necessary repair work requires that an itemized labor and parts ESTIMATE be provided to the Fleet Management Officer (FMO) at 360 Lincoln Avenue, Warwick, RI. Under no circumstances is repair work to be initiated without prior acceptance of the estimate by the FMO or his/her superiors as evidenced by the issuance of a work order authorization number. The State reserves the right to obtain repair estimates from alternated qualified vendors for any given work order. Any repair work completed without prior approval is the sole responsibility of the vendor; unauthorized invoices will be returned.
- ❖ Parts acceptable for use the fleet cited, or components thereof, are limited to new or rebuilt parts. Used parts are not acceptable. The State may request to inspect any or all replaced parts at any time prior to acceptance of the completed work order.

**AWARD**

THE STATE, AT ITS SOLE DISCRETION, SHALL RESERVE THE RIGHT TO MAKE ONE OR MULTIPLE AWARDS FOR THIS REQUIREMENT AND/OR TO REJECT ANY OR ALL BIDS.

**BIDDING** (a) A single price shall be quoted for each item against which a proposal is submitted. This price will be the maximum in effect during the agreement period. Any price decline at the manufacturer's level shall be reflected in a reduction of the agreement price to the State. (b) Quantities, if any, are estimated only. The agreement shall cover the actual quantities ordering during the period. Deliveries will be billed at the single, firm, awarded unit price quoted regardless of the quantities ordered. (c) Bid price is net F.O.B. destination and shall include inside delivery at no extra cost. (d) Bids for single items and/or a small percentage of total items listed, may, at the State's sole option, be rejected as being non-responsive to the intent of this request. **ORDERING** (a) The User Agency(s) will submit individual orders for the various items and various quantities as may be required during the agreement period.
