- 1.2 Material: Serge Wool 85% Acrylic, 15% Wool
- 1.3 Color: Black
- 1.4 Sizes: 6 5/8 thru 8

2. APPLICABLE SPECIFICATION: There are no other specifications applicable to this specification.

SPECIAL REQUIREMENT: Department of Corrections insignia or logo to be embroidered on cap as required by Department. Embroidery shall be silver on Correctional Officer Cap. Embroidery shall be Gold on Superior Cap.

3. REQUIREMENTS:

- 3.1 Style: Baseball; open back pro design pattern.
- 3.2 Construction: Heavyweight haircloth; six quarter sectional, reinforced two front panels. Embroidered eyelets; 4-ply 1 3/8" cloth sweatband, pro style insertion; .75" thick unbreakable, shape retention visor; 8 rows of lock stitching through the visor.
- 3.3 Workmanship: Shall be first quality, free from any defects affecting appearance.

- 4.1 Inspections: Caps will be inspected at point of delivery


5. PREPATATION FOR DELIVERY:

BID SAMPLES: Buyer, subsequent to bid opening, will instruct (3) lowest bidders to submit samples. Samples shall not be submitted with bid.


