



The requirement is sample collection and analysis

120 represents the anticipated number of samples collected/analyzed each fiscal year. The scheduled quarterly testing includes 100 tests for the Pastore Campus (25/qtr from a variety of buildings on campus) and 16 for the Zambarano campus (4/qtr primarily from the Wallum Lake House Building). Based on the tests results, retesting may be required. (Anticipated 4/year).

The Pastore samples are taken from faucets (all but one from the hot water tap). The Zambarano samples are taken from faucets and showers.
