



## STATE OF RI – SPECIFICATIONS FOR FLAGS

### 1. STATE OF RI FLAGS

Material of corded bunting, thread count 56/68, finished material wt. 2.83 oz. sq. yd., 12" x 18", one sided, standard four (4) staples, white background 2/2 color imprint blue shield, letters, stars and outline of scrolls and gold scrolls, anchor and border of shield.

State of Rhode Island Shield-Hope, colors to be fast to weather with mercerized finish.

Flags will have 1/8" hems at top and bottom and 1/2" hem at fly end. Selvage need not be hemmed. White cotton muslin sleeve sewn to flag with two rows of double stitching per inch (minimum).

Staff shall measure 3/8" diameter, 30" long and shall be made of natural white hardwood. Gilded wood spear attached to end of staff.

Flags shall be first quality, free from defects affecting appearance.

One dozen flags per bundle wrapped with brown paper. Each carton packed with maximum of 5 gross.

Available packaging – 3 gross/carton or 1 gross/carton. Agency to advise vendor of selection.

### 2. FIFTY STAR U.S. FLAGS, STANDARD, 4 STAPLES, 12" X 18"

Material of corded bunting, thread count 56/68 finished material, wt. 2.83 oz. sq. yd. Red stripes with blue field on bleached white background, colors to be fast to weather, with mercerized finish, (450 gross/year).

Flags will have 1/8" hems at top and bottom and 1/2" hem at fly end. Selvage needs not be hemmed. White cotton muslin sleeve sewn to flag with two rows of double stitching per inch (minimum)

Staff shall measure 3/8" diameter, 30" long and shall be made of natural white hardwood. Gilded wood spear attached to end of staff. Flags shall be attached to staff by 4 staples

Flags shall be first quality free from defects affecting appearance.

One dozen flags per bundle, wrapped with brown paper, each carton packed with maximum of 5 gross.




Diagram not to scale - State of R.I. Flag

It is the Vendor's responsibility to check and download any and all addenda from the RIVIP. The signed Certification Cover Form must be attached to the front of the offer. When delivering offers in person to One Capitol Hill, vendors are advised to allow at least one hour additional time for clearance through security checkpoints.

**PURCHASE AGREEMENT BID**

**BIDDING** (a) A single price shall be quoted for each item against which a proposal is submitted. This price will be the maximum in effect during the agreement period. Any price decline at the manufacturer's level shall be reflected in a reduction of the agreement price to the State. (b) Quantities, if any, are estimated only. The agreement shall cover the actual quantities ordering during the period. Deliveries will be billed at the single, firm, awarded unit price quoted regardless of the quantities ordered. (c) Bid price is net F.O.B. destination and shall include inside delivery at no extra cost. (d) Bids for single items and/or a small percentage of total items listed, may, at the State's sole option, be rejected as being non-responsive to the intent of this request. **ORDERING** (a) The User Agency(s) will submit individual orders for the various items and various quantities as may be required during the agreement period. (b) Exception - Regardless of any agreement resulting from this bid, the State reserves the right to solicit prices separately for any extra large requirements for delivery to specific destinations.
