Description:

Package shall consist of two (2) Avon ST53 multirole respiratory protection systems each with FM53 masks and attachable Avon Powered Air Purifying Respirator and 45-minute carbon fiber air cylinders with valves.

In addition, there shall be an additional four (4) Avon FM53 masks and an additional two (2) 45-minute carbon fiber air cylinders with valves. There shall also be twelve (12) each CBRNF12 filters and CSCF50 filters.
