1. Size for Type B1 Double-Faced, reads: 4'6" x 4"(inches)

It should read 4'6" x 4' (feet)

Confirm Typo error

**A. Should read 4'6" x 4' (feet)**

Q. B. Sheet 9 of 10, figure 12.2 Sign Details

1. Delete detail S1 as Base Bid Design.

The configuration does not meet structural standards for signage over 6 sq feet

**A. Delete detail S1.**

2. Detail S2- 3" extruded frame with retained faces should be used for the Standard for all Post & Panel signs.

**A. Use detail S2-3" extruded frame with retained faces.**

3. Drawing Elevation for sign types B2 & B3

**A. Delete reference to bituminous coating on Aluminum Posts.**
