

- (a) Rate per live mile. Miles travelled with passengers on board (actual miles travelled).
- (b) Waiting time per hour. The period of time between the Arrival and departure from the designated destination on any single day trip, or as the time spent on location between transportation shifts.
- (c) Overnight charge as required. The charge will be imposed to cover the expense of room, parking, meals, etc. For a driver and the bus on any given overnight.

### **School Bus Safety Enforcement RFP**

Rhode Island General law 31-51-1 entitled School Bus Safety Enforcement Act permits all school departments in Rhode Island to install and operate live digital video school bus detection monitoring systems, the State of Rhode Island hereby requires the school buses under this RFP include the installation, maintenance and monitoring of live video technology that will identify School Bus stop arm violations including preparation of evidence files for review and ticket issuance by law enforcement.

This bid requires that detection monitoring technology equipment be installed on a minimum 5% of the school bus fleet as agreed upon by the parties, with installation to begin no later than August 1, 2010. Said equipment shall include an outside or external housing unit containing one or more cameras designed to record and monitor traffic for live monitoring, signage as required under RIGL 31-51 and internal cameras which will record student activity on the bus and transmit such recordings directly to archive storage for potential review by State employees as needed.

All systems installed, violations issued and revenue generated must comply with the requirements of RIGL 31-51 for the purposes of inclusion in this bid.

### **Operational Requirements**

The selection of particular buses within the fleet shall be selected by the entity that is awarded the bid with the input of the State of Rhode Island and any third party transportation provider with knowledge of safety requirements and high risk routes.

The entity that is awarded the bid shall provide training to the State of Rhode Island and/or third party transportation provider on the use, maintenance and operation of the digital monitoring technology system.

The entity responsible for fulfilling this section of the specification shall be responsible for the installation, maintenance and daily monitoring of such systems.

The entity that is awarded the bid shall maintain property insurance on the digital monitoring technology system for theft, vandalism and damage from accidents and other loss.

The reimbursement for any and all revenue that is received as a result of school bus stop arm violations shall be in accordance with RIGL 31-51. Such reimbursement shall be made directly from the State of Rhode Island to the vendor of the school bus video monitoring technology. The share of net revenue shall compensate the entity that is awarded the bid for the expense of the services and the equipment provided by the entity.

The entity that is awarded the bid must be set up for all appropriate payment distribution with The Traffic Tribunal whereby distribution of fees collected shall be distributed to said entity within 30 days following the end of each month during the term of said agreement.

The entity that is awarded the bid must within 15 days following the end of each month during the term of the agreement provide the State Agency with monthly reports, including without limitation a statement of collections and distributions to be made for such month containing all information required to be reported by the School department pursuant to RIGL 31-51
