-This is a public works project and as such requires a CD be submitted along with the paper copy of your bid. Instructions on how to do that are included in the bid package.

-Please note the clauses that pertain to public works projects.

-Within the bid package is a **GENERAL CONTRACTOR APPRENTICESHIP CERTIFICATION FORM** that is required to be submitted with your bid proposal. There is a **SUBCONTRACTOR APPRENTICESHIP CERTIFICATION FORM**. This form must be completed and submitted to the general contractor before any work commences. The form does not come back to purchasing. At the time of tentative letter of award purchasing will require that the **GENERAL CONTRACTOR APPRENTICESHIP RE-CERTIFICATION AND CERTIFICATION FORM** be submitted along with other documentation.
