

-Included is a bid preparation check list to help you. It is not a substitute for a thorough review of the instructions to bidders.

-We are also asking that you submit a new state w-9. This is different from a federal w-9 and is available in the bid package.

Notes from the pre bid conference:

-This is a non-secured building (total of 2 floors), however ID Badges will be required and vendor employees will require a BCI check (at the vendor's expense).

-Windows will be white, clear glass, no grilles. If the windows come with screens that is fine, but screens are not required.

-The rooms (6) where the windows are to be replaced are at the end of each wing. There is a total of 30 windows (double windows), 5 per room.

-Vendor is only responsible for removing and replacing existing windows (old windows will be disposed of by the DOC as part of their recycling program). DOC will move any furniture if required, take out existing A/C units, remove shades, etc.
