- Questions are being accepted on line until 8/31/15 at 5pm. Instructions on how to submit questions are in the bid proposal. **(NONE RECEIVED)**
- Bid bond is required.
- Payment and Performance bond is required.
- Specifications are posted in pdf format on the website
- This is a public works project and as such requires that your bid, in addition to the paper copy, requires a CD be submitted also. Failure to do so will result in your bid being disqualified.
- In addition to the request for quote sheet where you are being asked to submit a total price there is an additional sheet that needs to be submitted with unit pricing.
- Please note the Public Works Bid Clauses.
- This is a prevailing wage project and there is a form in the bid documents that needs to be submitted with your bid proposal which is an acknowledgement that you are aware of the prevailing wage requirements.
- There is a Bid Preparation Checklist to help you out but it is not a substitute for a thorough review of the bid proposal by the vendor.
- We are asking you to submit a W-9 with their bid proposal.

Discussed in pre bid conference:

- Exact location of new fuel island to be determined.
- The current fuel island should be kept active as long as possible.
- Completion date for this project should be by June 30, 2016.
- All equipment is to be new.
- There has been a change to the scope of work from previous similar bids. It is the vendor's responsibility to become aware of any changes.
