in order as indicated in the bid package. Project 2 is the SPREADING OF STOCKPILED MATERIAL ON THE SALT MARSH AREAS. Vendors may bid on project 1 or 2 or both.

Please note what is required to be submitted on pages 24 and 25 of the RFP.

The winning bidder will need to be registered with the RI Sec of State before a PO can be processed. This can be done after the fact. Does not need to be done before hand.

At the bid opening I will only be acknowledging the names of vendors who submit proposals.

The goal of the project is to apply sediment to the marsh with the minimum damage and scour of the existing marsh surface. The project has requested the use of an 8" dredge, however given the project window and production rates of the specified dredge, the State will accept the use of a 10" dredge so long as the flows are split and diffused to limit the impacts to the marsh.
