AGENCY: DEPARTMENT OF CORRECTIONS
ADULT CORRECTIONAL INSTITUTIONS

SUBJECT: Slacks, Uniform (Winter)

FABRIC: Raeford #645-186 or equal; 55% Dacron/45% Wool 16 ½ - 17 oz.

COLOR: Slate Grey

STYLE: Same style as men's trousers, but on a women's pattern and to have five (5) belt loops and no watch pocket. Slacks shall be manufactured from up-to-date patterns and shall be designed so that there will be no "peg" at the hip or baggy seat. The front shall be plain (no pleats) with two (2) ¼ top pockets, and two (2) hip pockets. The left hip pocket shall have a tab to button. The front pocket shall have a minimum opening of 6 ½" and shall be 6" deep from the bottom of the opening. They shall be stitched, turned and top stitched. The hip pockets shall have an opening of approximately 6" from bartack to bartack and shall be 6" deep. Hip pockets will be of the double welt method manufactured on Reece P.W. Machine and shall be finished in such a manner that there is no topstitching. The welts shall be interlined with Pellon. All four (4) pockets must have a firm, straight bartack for reinforcing strength.

POCKETING: The pocketing shall be 50% Polyester 50% cotton blend, minimum 2.70 weight with a minimum 70 x 60 count. The color of the pocketing shall be black, so as to be the same color or a contrasting color to the outer fabric. White or off-white color pocketing will not be acceptable.

WAISTBAND: Waistband curtain to be of the same fabric as the pocketing (black, 50% Polyester, 50% cotton) and shall close with a hook and eye. The waistband curtain must be attached to the trouser with a zigzag stitch. The waistband must have a 3-strand rubberized stitch (Snug-tex) and contain Ban-rol.

FEMALE - SLACKS (WINTER)

- FLY LINING:** The right fly shall be of the same fabric and color as the waistband and pocketing. The right fly lining must be sewn to the left fly below the zipper with strong closure on the inside of the right fly and the fabric for the French Fly must be the same as the outer material of the slacks.
- BELT LOOPS:** There shall be a minimum of five (5) belt loops 5/8" wide. All loops (except for the black center loop) must be sewn into the bottom of the waistband and the top of all loops shall be caught into the waistband curtain seam. The waistband shall measure approximately 2" wide when finished -- wide enough to comfortably accommodate a belt 1-5/8" wide.
- SPECIAL REQUIREMENTS:** Braid to be one inch black on outseam of trousers from inside the waistband to bottom of pants and turn over. Braid to be colorfast and preshrunk.
- BOTTOMS:** Plain finished bottoms to include cloth heel guards.
- MISCELLANEOUS:** Slacks must have a Talon #42 Memory lock zipper and there shall be a bartack at the bottom of the fly going through the zipper tape. The slacks must be seamed with matching thread and the seat seam must be stitched with a tandem needle machine (2 threads). All exposed inside edges must be serged.
- PRESSING & FINISHING:** Slacks must be properly pressed on hothead presses and properly shaped. The outseams and inseams must be pressed open. Slacks that have been chemically treated at the Mill for special pressing instructions shall be pressed in accordance with such Mill instructions, including those that require water spraying prior to leg pressing operation to insure a longer lasting crease and proper wrinkle resistance.
- SIZE TAGS:** The slacks must have a care label permanently affixed and also have size label showing fiber content and WPL number.

- STYLE:** Trousers shall be manufactured from up-to-date patterns and shall be designed so that there will be no "peg" at the hip or baggy seat. The front shall be plain (no pleats) with two (2) ¼ top pockets, with watch pocket and (2) hip pockets.
The left hip pocket shall have a tab to button. The front pocket have a minimum opening of 6 ½" and shall be 6" deep from the bottom of the opening. They shall be stitched, turned and top stitched. The hip pockets shall have an opening of approximately 6" from bartack to bartack and shall be 6" deep. Hip pockets will be of the double welt method manufactured on Reece P.W. Machine and shall be finished in such a manner that there is no top stitching. The welts shall be interlined with Pellon. The watch pocket shall have an opening of approximately 3" and be approximately 3" deep and must be located approximately 3 ½" in front of the right side seam at the waistband. All five (5) pockets must have a firm, straight bartack for reinforced strength.
- POCKETING:** The pocketing shall be 50% Polyester 50% Cotton blend, minimum 2.70 weight with a minimum 70 x 60 count. The color of the pocketing shall be black, so as to be the same color or a contrasting color to the outer fabric. White or off-white color pocketing will not be acceptable.

- SIDE SEAMS:** One inch wide black Rayon braid to be sewn over side seam from bottom of waistband to bottom of trousers. Braid to be colorfast and pre-shrunk.
- BOTTOMS:** Plain finished bottoms to include cloth heel guards.
- MISCELLANEOUS:** Slacks must have a Talon #42 Memory lock zipper and there shall be a bartack at the bottom of the fly going through the zipper tape. The trousers must be seamed with matching thread and the seat seam must be stitched with a tandem needle machine (2 threads). All exposed inside edges must be serged.
