Listed below are the Questions and the Answers we received regarding this Invitation to Bid.

1. Q. License requirements – The RFQ states that a copy of the license/permit should be submitted with the bid. Specifically what type of license/permit are you requesting? For instance, business license or licenses of nurses?
 - A. That statement is actually part of the Division of Purchases standard requirements. For this bid we are requiring all vendors to comply with all licensing or State permits required for this type of services. No license is required to be submitted with your bid response. THE BIDDER, BY SUBMISSION OF THIS BID, CERTIFIES THAT ANY/ALL WORK RELATED TO THIS BID, AND ANY SUBSEQUENT AWARD WHICH REQUIRES A RHODE ISLAND LICENSE(S), SHALL BE PERFORMED BY AN INDIVIDUAL(S) HOLDING A VALID RHODE ISLAND LICENSE.

2. Q. Insurance Requirements – Are bidders required to submit COIs with their bid response submission?
A. No, the successful bidder will be required to submit their Insurance Certificate prior to an award being made to them.
3. Q. Page 2 of 2, the bottom lines indicating delivery and terms of payment – Do these items need to be filled in?
A. The delivery is not required on this type of bid since it is a Blanket Requirement. However the vendor should complete the request for Terms of Payment.
4. Should responses consist of anything other than a signed RIVIP generated Bidder Certification Cover Form, license/permit, and copy of the Request for Quotation 7550093?
A. Vendors must return the RIVIP Bidder Certification Form and complete the Excel spreadsheet.
5. Q. Is there one MPA for all awardees or does each vendor have an MPA? I tried searching by key word using the link below, but I could not locate anything for the previous contract under "nurse" or "nursing."
A. This is not a Master Price Agreement (MPA). MPA's are for multiple agencies and not one specific agency or department. This will be an Agency Price Agreement (APA). This means only the Veterans Home is allowed to use this contract. No other group is allowed to use this contract.
