All bidders, must be an Avon factory authorized service and warranty center located within the proximity of sixty miles to the Rhode Island Department of Corrections (RIDOC) in order to be able to provide said warranty and service responsibilities in a timely fashion.

All bidders, upon award of the contract, must provide an AVON sizing tool for the respirator protection equipment that will be issued to members of the Correctional Emergency Response Team (CERT). Mask sizes will be determined as a result of the sizing process.

All bidders, upon award of the contract, must supply end user and Avon Technicians Certificate to the RIDOC CERT team. This training will also include the RIDOC Training Academy for continued fit testing of these products, utilizing the TSI Portacount system and providing two adapters, (PC50, C50), for the Avon Systems.

Avon offers a ten (10) year recertification on all PC50 & C50 protective mask. This warranty must be presented in writing to the RIDOC CERT Team.

The winning bidder of the contract shall have the ability to deliver all protective masks and components within a four (4) week period from the date of receiving the purchase order (P.O.).
