There appears to be a discrepancy of the room numbers being done at the Armory.
The Specifications page 1 of 4 lists the rooms to be done in the 'work to be accomplished' paragraph.

Page 3 and 4 of 4 under 'additional information' shows a listing of the rooms with rooms 104,102,184,151 and 150 not appearing on the first listing of offices to be done on page 1

Compounding the issue, the first list include rooms 133,185 and 139 that do not appear on the second list.

Can you please clarify which rooms are to be done?
