Specification Change /Addition / Clarifications

In consideration of the issue relating to third shift work schedule I would propose the following replacement of GENERAL CONDITIONS Summary page 01 1000-2 paragraph D.

“D. Time Restrictions: The faculty and staff in Tyler Hall will continue to be delivering the academic program while this project is underway. The contractor shall perform their work in such a manner and schedule so as to not inhibit this continued use and access. To the extent that the contractor may choose to perform some of their work on a third shift schedule, 9PM to 7AM, or otherwise on a premium time schedule; that obligation and cost will remain solely with the general contractor and costs included within their submitted base bid. Should there be any interference with the ongoing and continued use of Tyler Hall by the faculty, staff or students; the University will direct the general contractor to perform their work at off-shift premium hours with no additional cost to the University. To the extent that the University will allow the general contractor to propose partial reductions in public spaces for planned work; that work may only be approved at the University’s sole discretion and the general contractor will be required to post written public notice of any planned partial encroachments into these public spaces. This effort too, will not allow for any premium or additional charges to the general contractor.
