All proposals must be submitted on the Proposal Forms as provided. Proposals shall be submitted in duplicate with required bonds.

No bidder may withdraw his bid within 60 days after the actual date of the opening thereof.

Bidder's attention is called to the Instruction to Bidders and Supplementary Instructions to Bidders. Failure to review these documents and all other bidding and contract documents will not relieve parties of the contractual requirements contained therein.

The Drawings and Specifications may be examined and picked up during normal business hours at the Rhode Island Building Code Commission from 2/28-3/17/06. Copies thereof may be obtained upon payment of \$50.00 for each set. Checks shall be made payable to the Rhode Island Building Code Commission. Payment will be refunded upon returning such sets in good condition within two weeks of bid opening.

Bidder is required to provide a Bid Security in the form of a Bid Bond, or a certified check payable to the State of Rhode Island, in the amount of a sum not less than five percent (5%) of the Bid Price. Performance Bond of One Hundred Percent (100%) of the Contract price and a Labor and Material Bond of One Hundred Percent (100%) of the contract price with a satisfactory surety company will be required of the successful Bidder.

There will be a Pre-bid Conference on 3/10/06 10:00 AM at the Charho Career & Technical Ctr., 459 Switch Road, Wood River Junction, Charho, RI.

Bidders' attention is referred to the State requirements pertaining to conditions of employment to be observed, including the requirement that ten percent (10%) of the dollar value of the work to be performed by Minority Business Enterprises, and wage rates paid under the Contract for this project, as on file in the Rhode Island Department of Labor, Office of the Director. Bidders are subject to terms, conditions, and provisions, of Chapters 2, 12, 13, and article 14.1 of Title 37, General Laws of the State of Rhode Island 1956, as amended.
