**1. CLASSIFICATION AND SCOPE:**

1.1 This specification covers Men's, Boy's and Youth's Leather Joggers, Sneakers, Low Cut.

**1.2 Description: VELCRO LEATHER SNEAKERS:**

**Type 1. Low Cut shall be 3 ¾" - 4" high (measured from the heel), cushioned insole and arch, two strap Velcro closure, fully lined with Velcro, no metal or plastic loop holes.**

**2. CONSTRUCTION:**

2.1 **Sole:** Non marking polyurethane

2.2 **Collar, tongue and foot bed:** Padded

2.3 **Heel Pad/Arch Support:** Cushioned

2.4 **Insole:** Cushioned

2.5 **Eyelets:** None

2.6 **Ventilation:** None

2.7 **Stitching:** Eyebrow: double row each side 1/16" - 1/8" apart.  
Top: double row, 1/16" - 1/8" apart.  
All stitching shall be 7 - 8 stitches/inch.

3. **COLOR:** A) White  
B) Black (as specified by using agency)

4. **SIZES:** 6 - 15 Medium width.

5. **LABEL:** Footwear shall have a permanent brand and size label.

6. **QUANTITY:** As specified in the Invitation for Bids.

7. **APPLICABLE SPECIFICATION:** There are no other specifications applicable to this specification.

8. **WORKMANSHIP:** Footwear shall be first quality, free from any defects affecting appearance or serviceability.

**9. SAMPLING AND INSPECTION:**
