SEALED PROPOSALS ADDRESSED TO THE STATE PURCHASING AGENT, 1 CAPITOL HILL, PROVIDENCE, R.I. 02908-5855, SHALL BE RECEIVED UNTIL 2/5/08 at 1:45 PM At that time they will be opened and read in accordance with public bidding procedures.

BIDS SHALL BE SUBMITTED IN DUPLICATE ON THE FORMS PROVIDED WITH THE PLANS AND SPECIFICATIONS. Plans and specifications for submitting bid proposals may be obtained from the **State Building Commission, 2nd Floor, 1 Capitol Hill, Providence, R.I.** Plans and Specifications may be examined at the Offices of the Department of Environmental Management, Division of Planning & Development, 235 Promenade Street, Third Floor Room 320, Providence, Rhode Island, every day except Saturdays, Sundays and Holidays between the hours of 8:30 A.M. and 4:00 P.M. from 1/3/08 to 1/29/08. Plans and specifications may be obtained from the State Building Commission from 1/3/08 to 1/29/08.

Bid Documents may be examined at the office of the Architect, and the Rhode Island State Building Code Commission, One Capitol Hill, Providence, RI 02908. Bid Documents, in the form of a CD, may be obtained from the office of the Building Code Commission at no charge.

A certified check or **BID BOND**, payable to the State of Rhode Island in an amount equal to **FIVE PERCENT (5%)** of the proposal shall be submitted with the bid.

A **PERFORMANCE** and **PAYMENT BOND** equal to **ONE HUNDRED PERCENT (100%)** of the Contract price, with a surety company registered and licensed in the State of Rhode Island, shall be required of the successful bidder.

This project is subject to Chapter 37-14.1 of Rhode Island General Laws et. seq., and regulations promulgated thereunder, which require that ten percent (10%) of the dollar value of work performed on the project be performed by minority business enterprises, and prevailing wage rates to be paid under the Contract for this project must be in accordance with those prevailing wages on file in the Rhode Island Department of Labor, Office of the Director.

Representatives of the Department of Environmental Management, Division of Parks and Recreation and Division of Planning and Development will be present at the **#2 Toilet at Colt State Park** on January 22, 2008 **at 10:00 A.M.** for a **Pre Bid Conference**.
