Buyer's introductory remarks:

- This is a non-mandatory pre-bid conference
There may be other bidders not at this meeting.
- Questions are being accepted on-line until 1/20/20 at 5pm. The email address and instructions how to submit questions is on the bid proposal.
- Bid bond is required
- Performance bond is required
- Specifications and plans are posted on the website.
- This is a public works project and as such requires a CD be submitted along with the paper copy of your bid. Instructions on how to do that are included in the bid package.
- Please note the clauses that pertain to public works projects.
- This is a prevailing wage project. Note the certification within the bid package that acknowledges you are aware of your obligations as they pertain to prevailing wage.

Notes from pre-bid conference:

- It will be important for the awarded vendor to work closely with the agency when work commences as the facility needs to maintain its daily operation.
- Work is intended to start in the spring when plants open.
- There is no concrete work in this bid. The concrete in front of the doors stays and the concrete around the fuel depot is another agencies responsibility.
- All reclaimed material stays on site. Nothing is to be removed.
- There is no curb reset. There is no striping.
- The intended goal of this project is to pitch water run off away from the building.
- There is no work inside of any buildings.
- Another addendum will be posted better defining the boundaries of the project.
- While vendors may revisit the site to measure the work area the agency will not be answering any questions and the written word in the bid posting takes precedent.

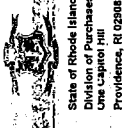
