### **B. REVISION**

- 1. Attachment D Cost Proposal Attached <u>ATTACHMENT D COST PROPOSAL</u> <u>FORM REV 2/22/17</u> shall replace previously provided ATTACHMENT D REV 2/10/17 in its entirety. The following are items address in the revised form:
  - a. Sheet 2 AET Deployment Costs Additional Allowance Line Item for Utility Preliminary Engineering Services has been added. Description of allowances has been updated.
  - b. Sheet 5 Direct Labor Rates Duplicate category for "Maintenance Technician Supervisor" has been removed.

- 2. Attachment A Contract Terms, Section 14.3 Payment for Operations & Maintenance, Item b shall be replaced with the following:
  - b. For Operations The total annual Lump Sum for the corresponding year of Operations services divided by 12.
- Attachment A Contract Terms, Section 6.1 ENVIRONMENTAL REV 021017 shall include the following subsection confirming RIDOT's responsibility to obtain NEPA approvals:
  - "6.1.4 RIDOT's Responsibility to Obtain Environmental Approvals

Notwithstanding any other requirements specified in the Contract Documents, Contractor shall not commence final design or any construction activities at any Toll Point prior to RIDOT obtaining the necessary environmental approvals as per FHWA Order 6640.1A FHWA Policy on Permissible Project-Related Design Activities During the NEPA Process.

4. Attachment A – Contract Terms, Section 15.10.1, Differing Site Conditions, first sentence shall be deleted. Section 15.10.1 shall now read:

"Subject to the limitations contained in and upon Contractor's fulfillment of all applicable requirements of this SECTION 15, RIDOT shall be responsible for and agrees to issue Change Orders to (a) compensate Contractor for additional costs incurred arising from the need to address subsurface obstructions; and (b) extend the time for completion of the Work as the result of any delay in the critical path caused by a differing Site condition to the extent that it is not possible for Contractor to work around the problem."

5. Attachment A – Contract Terms, Section 22.1(h) has been modified to clarify Contractor references with the following:

"THE CLAIM OR ASSERTION BY ANY OTHER (i) RIDOT CONTRACTOR THAT ANY CONTRACTOR-RELATED ENTITY INTERFERED WITH OR HINDERED THE PROGRESS OR COMPLETION OF WORK BEING PERFORMED BY SUCH OTHER OR FAILED TO COOPERATE REASONABLY WITH SUCH OTHER CONTRACTOR, SO AS TO CAUSE INCONVENIENCE, DISRUPTION, DELAY OR LOSS, EXCEPT WHERE THE CONTRACTOR-RELATED ENTITY WAS NOT IN ANY MANNER ENGAGED IN PERFORMANCE OF THE WORK OR (ii) CONTRACTOR THAT ANY CONTRACTOR-RELATED ENTITY INTERFERED WITH OR HINDERED THE PROGRESS OR COMPLETION OF WORK BEING PERFORMED BY SUCH OTHER CONTRACTOR, SO AS TO CAUSE INCONVENIENCE, DISRUPTION, DELAY OR LOSS, TO THE EXTENT SUCH CLAIM ARISES OUT OF THE ACTUAL OR ALLEGED CULPABLE ACT, ERROR, OMISSION, NEGLIGENCE, BREACH OR MISCONDUCT OF ANY CONTRACTOR-RELATED ENTITY;"

## C. CLARIFICATION

1. Clarification to previously asked question regarding construction project information in proximity to tolling locations.

RIDOT is not able to provide specific information at this time.

2. Clarification to previously asked question regarding identification of proprietary or confidential information in the proposal.

Proposal material, in part or in its entirety shall be conspicuously labeled as Confidential or Proprietary and will be redacted upon public access request. It is the Proposer's responsibility to properly label and identify the Confidential or Proprietary information. For any electronic files, the file name shall contain the term "Confidential" or "Proprietary".
