1. BRIEF SCOPE OF WORK

Rhode Island Contract No. 2017-CM-030, Federal Aid Project No. 405-421-840, is for washing 74 bridges statewide. The work is located in the Counties of Providence, Newport, Washington, and Kent in the Cities or Towns of, Coventry (1), Cranston (3), Cumberland (4), East Greenwich (7), East Providence (6), Exeter (2), Hopkinton (7), Lincoln (3), North Kingstown (10), Pawtucket (3), Providence (14), Richmond (4), Smithfield (3), Warwick (4), West Greenwich (3), Rhode Island. This contract includes, but is not limited to, high-pressure water washing of bridge decks, sidewalks, guardrail, backwalls, beam seats, beam ends*, parapets, piers in their entirety, abutment faces, wing wall faces, bearing devices, structural steel, concrete beams, diaphragms, slope paving blocks, drainage features such as scuppers, girders, cross frames, utility supports, utility pipes and conduits, sealing (protective coating) of substructure, parapets, barriers, concrete surfaces, inlet protection, and providing traffic control at all work locations; and selective clearing as identified in the contract documents.

* "Beam Ends" means within 6 feet of centerline of bearings.

2. CONTRACTOR'S QUALIFICATIONS

The Prime Contractor is required to meet the following requirements in order to qualify as a responsible bidder for the proposed maintenance cleaning and washing of bridges. The Prime Contractor shall have a minimum of five (5) years of experience in the maintenance cleaning and washing of bridges and/or projects of similar complexity. The Prime Contractor shall provide evidence of three (3) similar projects that have been successfully completed in the last five (5) years. Copies of the experience shall be provided. References for experience shall be provided and shall include the name, address, and telephone number of a contact person employed by the bridge owner.

3. TRANSPORTATION MANAGEMENT PLAN

All traffic control setups shall conform to the MUTCD. Typical details have been provided. The Contractor shall provide and submit for review traffic control setup details for locations where the typical details do not apply.

Included as an appendix to these Contract Specific General Provisions is the Transportation Management Plan (TMP) for this project. The TMP lays out the set of coordinated transportation management strategies that will be used to manage the work zone safety and mobility impacts of this project. In the event of a discrepancy between information in the TMP and information elsewhere in the Contract Documents, the former shall govern.
