-The contract times are listed on the bid form. There is a time constraint issue that Andres will explain.

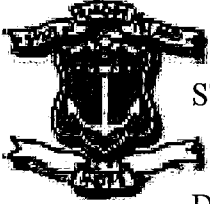
-There are liquidated damages of \$800 per day, also indicated on the bid form.
