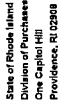
An issue was raised concerning UL 752 vs FEMA 361 standards. Meeting or exceeding the UL 752 ballistics standards trumps the FEMA hurricane standards. The intent of these doors is to prevent casualties from an active shooter, not withstand damage from a major hurricane.

Multiple crews can work at the same time.

In the event a door replacement is going to exceed one day; the vendor is responsible for securing the building from the weather (ie tarp). The agency will be responsible for handling any security issues.

FMO maintenance did a test of the Warren Armory's front door construction. The current frame set-up is bolted into wood which is anchored into the block opening. The actual block dimensional opening for the front entrance measures as: Width = 70" inches, Height is 86" inches from the concrete floor to the header. FMO / ESS would be looking to have the new frame marry up to the concrete block.
