MPA# 40 - Plumbing Services, Maintenance and Repairs

1. Could you please clarify if the Bid Sheet included within the RFP is a required document in the bid submission? There are a number of items which are not relative to plumbing services. It appears that this was not included in previous submissions.

Answer: The bid sheet is required to be submitted. However, it is not necessary to bid every line item. Many of the items are for equipment and are being gathered for informational purposes.

2. does this include all the D.O.C work as well?, being State owned properties?

Answer: Currently, the Department of Corrections (DOC) has a specific contract for this work. However, as this is a statewide MPA, all state agencies including DOC, as well as political subdivisions (cities, towns, schools, quasi-public agencies) as authorized by law, may participate in this agreement.

3. this MPA 40 RFP can or cannot be submitted in the form of a Hard paper copy, or just pdf file only?

Answer: A hard copy of bid submissions is required to be submitted to the Division of Purchases no later than the time and date listed on the solicitation. It is requested that an electronic file (Excel format) of the bid sheet be submitted along with the hard copy.
