1. Does this job require a bond at time of submittal?

Answer: This solicitation does not require a bond.

2. No line items for fire alarm testing at Capitol Hill Complex

Answer: Fire alarm testing and the list of buildings included in "Capitol Hill Complex) are included in Section Two (pages 17-18) of the bid package. All the buildings listed in section two are included the Capitol Hill Complex. Please bid accordingly on the Bid Sheet #7596691 lines Section 2 lines 206-253. The Powers Building Cafeteria (misspelled on the bid sheet) is included in the Capitol Hill although bid separately.

3. No line items for fire alarm testing at 50 Service Avenue

Answer: The DoIT Operations Center / 50 Service Ave should have been included in Section 1, Subsection 2 with the Pastore Center. The Section 1, Subsection 2 should have been titles "Central Region". Pastore Center, Cranston should be ignored. Section 2 Subsection 4 has the line items for DoIT Center / 50 Service Ave. Warwick. Please bid line items on Section 2 Subsection 4, lines 262-285 on "Bid Sheet #7596691.

4. No line items for fire alarm testing at Stedman Building

Answer: The Stedman Center line items covered in Section 2 sub section 4 & % are incorrect. Both the sprinkler system and fire alarm have been installed. Please refer to the Bid Sheet # 7596691, Section2, Subsection 6 lines 286-305 for bidding. Section 2 subsection 7 should be ignored as it is a repeat of lines 298-305 in Section 2 subsection 6.

5. Thank you for the latest amendment but this is only the sprinkler information where is the fire alarm device reports?
