Questions from Syntech

1. Does the current fuel Island controller system have a mechanical or fiber optic connection to the dispenser?

Answer- mechanical connection

2. Are there existing conduits between the fuel Island controller system and the pump that can be utilized when the new system is installed?

Answer- No. Old conduits between fuel Island controller system and pump are not to be reused.

3. Are you currently connecting to the fuel Island controller system through a wired Ethernet connection or wirelessly?

Answer- Mostly ethernet but some locations may have a phone connection

4. Do you have a list of or the total quantity of assets that will be fueling across your fuel stations?

Answer- Yes, we have a list of vehicles that need to be fueled and quantity. There are approximately 3000 vehicles. Specifics will be provided to the winning bidder.

questions from EJ Ward regarding the Fuel Management RFP:

1. Vehicle automated devices: would this be something the state would entertain as part of this process to identify the vehicle and get mileage, diagnostic information and ECM Data?

Answer- No.

2. Based on the Thanksgiving Holiday and questions being due on the 15th would the state be open to an extension of the RFP Response?

Answer- No.

3. Can the existing pulsers be utilized for new Fuel Management System or do they need to be replaced?

Answer- No, we require that they are to be replaced.

4. Will the state provide network to the TLS to pull data from those existing Veederroot's

Answer- Yes, you may use the current hardware and communication lines.

questions from Service Station Equipment regarding the Fuel Management RFP:

1. Is it mandatory that the link between the pump and the controller be wireless?

Answer- We will consider alternatives.

2. What is meant exactly by "explosion proof"? What is the actual requirement needed (ex. Class 1 Div 2, or other)?

Answer- equipment Installed per Rhode Island fire and electrical codes would qualify something as "explosion proof".

3. What sort of operation are you looking for the phone app to provide? Having access to the main software, or other?

Answer- the phone app should be able to access data and fault codes for purposes of trouble shooting remotely.

4. What term do you prefer the Cloud subscription be billed (Ie, annual, biennial, quinquennial, etc)?
