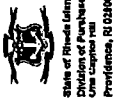

Add to Section 00 17 00 Execution Requirements 3.5 K. to read, "Existing work areas are occupied and there will be obstacles encountered that will have to be moved or worked around. Work area shall be covered to minimize dust/debris. Areas shall be cleaned at end of each work day. If an area is not cleaned the College may have their staff clean and back charge Contractor for costs incurred."
