**Per the issuance of this ADDENDUM #1 (4 pages) the following is noted:**

This addendum posts answers to questions allowed until 4/11/19 at 5pm.

This addendum posts bid tabulation from previous bid.

This addendum posts acknowledgement of addendum sheet which should be submitted with bid proposal.

Q. Is a performance bond required?

A. *No, only a bid bond (surety), which is returned after a purchase order is issued.*

Q. Would like to see the bid tabulation from the last bid.

A. *Attached to this addendum.*

Q. In past years DEM has allowed a small cart to be kept in a secluded spot near the bike path, chained up and covered. Is this still allowed?

A. *Per Section 4 (A)(2)(b) of the RFQ, new vending locations will be determined by the Division and awarded Concessionaire. Depending on determined vending location, DEM is agreeable to allowing cart (MFE) to remain at the vending location.*

Q. Under Menu offerings it states food and other beverage items are not allowed. Can pretzel sticks and potato chips be sold?

A. *1. Pretzels/Potato chips may be offered at Colt State Park only.*

*2. Pretzels/Potato chips may not be offered at Brenton Point as a separate beverage, food and sundry concession (MFE) is being solicited and will be awarded for the same term of this concession at Brenton Point.*

*3. Pretzels/Potato chips may not be offered at Fort Adams as a separate beverage, food and sundry concession has been granted to the Fort Adams gift shop.*

Q. Under Facilities and Service Payment methods it states "The concessionaire shall provide cash register receipts...." I only have a money box in the truck. Will this be a problem?

A. *No. However, if requested, Concessionaire must provide customer with a receipt. In addition, all reporting requirements listed under Section 4(M) of the RFQ will remain applicable.*

Q. Under reporting states "number of transactions by outlet." Our trucks cover different routes during the day and it would be difficult to count only the park. Is this a strict requirement?

*A. Yes. all reporting requirements listed under Section 4(M) of the RFQ will remain applicable*

Q. Under waste disposal, states vendor is responsible for positioning an adequate number of dumpsters and trash receptacles. This does not seem to apply. We do remove all of our trash. Please advise.

*A. Vendor is required to provide necessary trash receptacles and remove trash daily. Trash receptacles must be visible and accessible to customers. The vendor is responsible for trash removal within a 50' radius around the assigned vending location. Dumpster will not be required if trash is removed daily.*

Q. Under Rights not Exclusive states "the Division reserves the right to allow others to conduct concession operations....." Does this pertain only to special events held within the park or is it the intention of the Division to award contract to multiple vendors?

*A. This does not apply to special events only, however, we are not awarding this concession contract to multiple vendors. This language is to allow the State options.*
