MINIMUM SPECIFICATIONS FOR ON-CALL SPRAY POTHOLE PATCHING SERVICES

SCOPE OF WORK:

The State of Rhode Island is seeking the services of a vendor to supply agencies with a truck-mounted spray injection pothole patcher, complete with operator and materials on a daily on-call basis. The spray injection pothole patch truck specified herein shall be provided with a skilled operator and all required materials as specified to perform spray injection pothole patching on a daily on-call basis where directed by agency. The vendor shall verify they can provide a minimum of two (2) up to a maximum of five (5) spray injection trucks and operators on an as-needed basis within the time period specified below. The state estimates the annual usage will be approximately 3,000 total pothole patching hours. This number is an estimate based upon usage history and not a guarantee of annual hours under this contract.

The actual duration of the on-call period will be determined by the state and will be based on the demand required to support the agency needs. The state anticipates needing the pothole patch trucks for the entire year (12 months) weather permitting. Bidders made aware that RIDOT typically shuts down the pothole patch truck operations at a minimum through the holidays in December and January. It is important to note that winter storm operations take priority from November 15 through April 15 annually and the patch trucks will be shut down as determined by RIDOT during this time period.

The prospective vendors shall provide a cut-sheet and specification of the truck and materials proposed to be used as part of their bid package. The state reserves the right to accept or reject equipment proposed based upon their review of the information provided. If an alternate model and/or method are proposed, the alternate model and/or method shall meet all the specifications herein to be considered. The state may require a demonstration of any alternative/different model truck prior to considering award to that company.

The vendor shall supply a complete system with skilled operators and the proper materials that are required to perform spray injection pothole patching as specified herein. All trucks shall be in good working order prior to arrival at the designated daily work assignment. RIDOT will not pay for down time of the vehicle or its operator while the vehicle is down.

All services shall be provided at an hourly rate per truck based on an 8-hour workday Monday through Friday. This time may be adjusted as required when approved in writing by RIDOT or requesting agency. The hourly rate shall be all inclusive for a turnkey pothole patching operation; including, but not limited to, the spray injection truck, vehicle operator, aggregate and asphalt emulsion. Aggregate and asphalt emulsion quantities as well as GPS data for all potholes filled shall be provided to RIDOT on a daily basis for each truck in operation.

Regular 8-hour workdays shall be Monday through Friday between 7:00 AM and 5:00 PM. Some work may be required to be performed during overnight periods where it may be determined to be more efficient, due to traffic and/or safety concerns. Overnight hours will be work performed after 5:00 PM and before 7:00 AM.

To ensure the availability of the asphalt emulsion products, the vendor shall have its own dedicated heated delivery tankers. To maintain the integrity and quality of the asphalt emulsion product that is used in the application, the vendor shall have dedicated heated and metered delivery tankers so that there is a reduced potential of cross contamination of the emulsion product that can adversely affect the spray pothole patching application.

The vendor shall have a minimum of THREE (3) YEARS of verifiable experience providing the services equal to the services that are being requested by RIDOT and shall provide a minimum of THREE (3) references as part of their bid package. The vendor is responsible to perform all maintenance on the equipment to ensure 8 hours of productivity per day. RIDOT reserves the right to terminate use of any vendor, operator, or truck that fails to produce 8 hours of productive work consistently every day.

The vendor shall respond to the call for services within 24 hours of receiving the notice to proceed from the State of Rhode Island. Note: The vendor shall be required to supply services at multiple locations using more than one piece of equipment in any workday as requested by RIDOT. The vendor shall be capable of providing a minimum of two (2) patch trucks up to a maximum of five (5) with operators on any one day for the duration required by RIDOT.

RIDOT will provide locations of where pothole repairs are to be performed from the designated Agency Manager. RIDOT maintains approximately 3300 lane miles of highways statewide, and the On-Call service may be directed to any of these roadways statewide. Traffic control will be provided by RIDOT on all interstates, freeways and limited access highways and shall include a truck-mounted attenuator for each crew each day and a police detail where deemed necessary by RIDOT. The vendor shall provide their own traffic control on all other roadways and this cost shall be included in the hourly rate of the patch truck.

All pothole repairs made by the vendor shall be performed in accordance with road maintenance industry standards, and all pothole repairs shall be warranted against failure for a period of not less than 90 days. Any pothole repair that is identified to the vendor that has failed shall be repaired by the vendor at no additional cost to the state.

At the end of each workday, the vendor shall provide RIDOT with a computerized listing of the locations where the truck has completed repairs that shall contain (at a minimum): Time, Date and Location of the repair event. A geo-referenced location log shall also be provided so RIDOT can enter the repairs into their GIS.

The vendor shall perform quality control inspections to ensure the pothole patching program achieves the highest level of productivity and success attainable. The vendor shall provide RIDOT with a weekly progress report of all RIDOT activity.

The contract terms and pricing shall be valid for two (2) years, with a one (1) year option (pricing included) to extend the contract which may be exercised by the state at the conclusion of the year two work.

BID EVALUTION AND PRICING:

All bidders shall complete the *Minimum Bid Evaluation Criteria Data Form* which is included in this RFQ. Bids will be evaluated based upon daily production rates, hourly rate costs, estimated service life of the patch, warranty period provided and the bidder's demonstrated experience. The winning bidder shall provide RIDOT with the best performance value based upon these criteria.

Bidders shall provide invoices for the work completed statewide in the prior two (2) week period. These invoices shall include, but not be limited to, the tonnage of patch placed, labor and equipment utilized daily throughout the billing period, and the number of hours in operation for each day through the billing period.

MATERIALS AND EQUIPMENT STORAGE AND STAGING:

The vendor shall secure and retain a suitable facility within Rhode Island large enough to store all the contracted patching equipment, ancillary support equipment, and a minimum of 50 tons of washed, clean, dry aggregate materials inside and kept warm and dry, especially during cold weather periods for the duration of this contract. This facility shall be heated to a minimum of 55 degrees Fahrenheit at all times during the months of October through April. The cost of this facility shall be included as overhead and ancillary in the vendor's pricing for this contract. RIDOT shall not pay the vendor separately for the cost of this facility.

EQUIPMENT:

The spray injection patch truck system shall be kept clean and in good working order. The cleaning process shall be capable of being performed from within the cab of the patch truck and shall not incorporate the discharge of any materials in an unsafe or non-environmentally clean manner. The spray patch truck shall be equipped with automated controls so that the operator is not required to exit the vehicle to perform any application of the repair or cleaning process. The vendor shall be responsible for proper disposal of all waste materials resulting from the cleaning process. The patch truck shall have the ability to perform linear patching while moving in a forward direction. The patch truck shall be equipped with a directional arrow board-mounted on the rear of the vehicle capable of providing a visual warning to pedestrians and approaching vehicles. All patch trucks shall have a georeferencing system on board capable of marking and tracking all patches done by the vehicles and provided to RIDOT in a format compatible with RIDOT's GIS mapping system.

MAINTENANCE AND SUPPORT OF SPRAY INJECTION EQUIPMENT:

The vendor shall be responsible for the full performance capability of all equipment provided to perform the required services under this contract. The vendor shall perform all predictive and preventative maintenance on equipment when required at a time that does not interfere with the contract activity or impact the productivity of the operations. In addition, if a mechanical issue cannot be corrected *within* 24 hours, the vendor shall have the ability to provide a replacement vehicle to continue the pothole patching services. The state shall not be invoiced for non-productive vehicle time.

Any spray injection pothole patch truck submitted not conforming to these specifications will be rejected, and it will be the responsibility of the vendor to conform to the requirements unless deviations have been specifically cited by the vendor and acceptance made on the basis of the exceptions in writing by RIDOT.

Each complete spray injection pothole patch truck unit shall conform to the requirements of the federal motor vehicle code.

SPRAY PATCHING APPLICATION:

The truck-mounted asphalt spray patcher shall be designed and constructed to repair larger cracks, potholes and broad areas. The spray injection pothole patch truck shall be completely controlled by one person from the driver's position of the cab. This vehicle, including all materials, shall be capable of patching successfully at temperatures as low as 0 degrees Fahrenheit. Operational features of the equipment provided shall be designed to use air volume to complete steps 1-4 listed below:

- 1. <u>Clean</u> dust shall be removed from the pothole by high velocity air flow, creating a clean, hard surface.
- 2. <u>Tack</u> a mixture of air and asphalt emulsion (see ** below) spray shall be applied as a binder for the pothole repair.
- 3. <u>Fill</u> with a compact mixture of air, asphalt and aggregate that shall be applied at a high velocity to completely fill the pothole.
- 4. <u>Dry Coat</u> a mixture of air and aggregate or a recycled rubber material shall be applied to permit traffic on the repaired area without tracking. This is the final step on roadways.
 - **Asphalt emulsion shall be suitable for the weather conditions when being applied, even if ambient temperatures are below 0 degrees Fahrenheit.

AGGREGATE HEATING AND VIBRATING SYSTEMS:

The vendor shall provide an aggregate heating and an aggregate vibrating system to be used with the above equipment. The aggregate heating system shall allow the rock to remain free flowing in cold weather and freezing conditions.

The aggregate vibrator system shall allow for the dislodging of bridged material if the material becomes lodged in the aggregate hopper. These systems are necessary during winter or in adverse weather conditions to ensure a consistent distribution of aggregate is achieved.

AGGREGATE SYSTEM:

The aggregate storage tank shall hold a minimum of 5 cubic yards of aggregate. The tank shall be equipped with a cover to prevent aggregate from bouncing out while being transported and to seal the tank so it can be pressurized to equalize the pressure developed in the aggregate supply hose.

ASPHALT EMULSION FEED AND FLUSH SYSTEM:

The asphalt air system shall be pressurized to deliver asphalt to completely cover aggregate at full feed capacity. The delivery system shall be capable of maintaining 60 psi throughout the petroleum resistant delivery hose. The emulsion shall be drawn from the bottom part of the tank to maintain good circulation over the heat tube.

ENVIRONMENTAL CONTROLS:

The spray injection patch truck shall be equipped with a system designed to clear the emulsion lines of residue and incorporate a method to circulate a bio-degradable cleaning material through the asphalt delivery circuit for cleaning purposes. This process shall be capable of being performed from within the cab of the vehicle by the operator without having to exit the cab.

ACCOUNTABILITY REPORTING:

The spray injection pothole patch truck shall incorporate the necessary equipment to provide reports of vehicle positioning and tracking that can provide the following minimum data: Date, Time, Location with the POTHOLE FILL stamp in the report and the unit shall have the ability to receive and send text messages to the program manager for communication purposes.

OUALITY CONTROL EVALUATIONS:

The vendor shall perform a Quality Control Evaluation of each operator's performance during the patching activity to ensure the work is being applied in accordance with industry standards and that the expectations of RIDOT are being achieved.

ASPHALT EMULSION:

The materials supplied for the spray injection patch truck shall be compatible for the time of year when the activity is being performed.

Winter applications shall be considered when temperatures will remain below 50 degrees Fahrenheit.

The vendor is responsible for providing the proper material that provides the highest level of success during the conditions when the application is being applied. The vendor shall be capable of successfully performing spray patching when the ambient temperatures are below ZERO degrees Fahrenheit.

AGGREGATE:

Aggregate sizes for spray injection shall be AASHTO or ASTM size No. 9 (4.75 to 1.18 mm - No. 4 to No. 16) with no more than 3% passing the 75 urn (No. 200) sieve. Crushed aggregate material recommended for spray injection. Using an asphalt emulsion content of approximately 7% by weight of aggregate works best for warm weather conditions, while spray injection placed in winter conditions perform well at an asphalt emulsion content of about 5% by weight of aggregate.

The prevailing wage requirements are generally set forth in RIGL 37-13-1 et seq. These requirements refer to the prevailing rate of pay for regular, holiday, and overtime wages to be paid to each craftsmen, mechanic, teamster, laborer, or other type of worker performing work on public works projects when state or municipal funds exceed one thousand dollars (\$1,000).

Access the Department of Labor and Training website, at www.dlt.ri.gov on or before July 1st of each year, until such time as the contract is completed, to ascertain the current prevailing wage rates and the amount of payment or contributions for each covered prevailing wage employee and make any necessary adjustments to the covered employee's prevailing wage rates effective July Ist of each year in compliance with RIGL §37-13-8;
- 5. Attach a copy of this CONTRACT ADDENDUM and its attachments as a binding obligation to any and all contracts between the contractor and any

TITLE 37

Public Property and Works

CHAPTER 37-13 Labor and Payment of Debts by Contractors

SECTION 37-13-5

§37-13-5 Payment for trucking or materials furnished - Withholding of sums due. -A contractor or subcontractor on public works authorized by a proper authority shall pay any obligation or charge for trucking and material which have been furnished for the use of the contractor or subcontractor, in connection with the public works being performed by him or her, within ninety (90) days after the obligation or charge is incurred or the trucking service has been performed or the material has been delivered to the site of the work, whichever is later. When it is brought to the notice of the proper authority in a city or town, or the proper authority in the state having supervision of the contract, that the obligation or charge has not been paid by the contractor or subcontractor, the proper authority may deduct and hold for a period not exceeding sixty (60) days, from sums of money due to the contractor or subcontractor, the equivalent amount of such sums certified by a trucker or materialman creditor as due him or her, as provided in this section, and which the proper authority determines is reasonable for trucking performed or materials furnished for the public works.


SECTION 37-13-7

§ 37-13-7 Specification in contract of amount and frequency of payment of wages.

- -(a) Every call for bids for every contract in excess of one thousand dollars (\$1,000), to which the state of Rhode Island or any political subdivision thereof or any public agency or quasi-public agency is a party, for construction, alteration, and/or repair, including painting and decorating, of public buildings or public works of the state of Rhode Island or any political subdivision thereof, or any public agency or quasi-public agency and which requires or involves the employment of employees, shall contain a provision stating the minimum wages to be paid various types of employees which shall be based upon the wages that will be determined by the director of labor and training to be prevailing for the corresponding types of employees employed on projects of a character similar to the contract work in the city, town, village, or other appropriate political subdivision of the state of Rhode Island in which the work is to be performed. Every eontract-shall-contain-a-stipulation-that-the-contractor or his or her subcontractor shall pay all the employees employed directly upon the site of the work, unconditionally and not less often than once a week, and without subsequent deduction or rebate on any account, the full amounts accrued at time of payment computed at wage rates not less than those stated in the call for bids, regardless of any contractual relationships which may be alleged to exist between the contractor or subcontractor and the employees, and that the scale of wages to be paid shall be posted by the contractor in a prominent and easily accessible place at the site of the work; and the further stipulation that there may be withheld from the contractor so much of the accrued payments as may be considered necessary to pay to the employees employed by the contractor, or any subcontractor on the work, the difference between the rates of wages required by the contract to be paid the employees on the work and the rates of wages received by the employees and not refunded to the contractor, subcontractors, or their agents.
 - (b) The terms "wages", "scale of wages", "wage rates", "minimum wages", and "prevailing wages" shall include:
 - (1) The basic hourly rate of pay; and
 - (2) The amount of:

- (A) The rate of contribution made by a contractor or subcontractor to a trustee or to a third person pursuant to a fund, plan, or program; and
- (B) The rate of costs to the contractor or subcontractor which may be reasonably anticipated in providing benefits to employees pursuant to an enforceable commitment to carry out a financially responsible plan or program which was communicated in writing to the employees affected, for medical or hospital care, pensions on retirement or death, compensation for injuries or illness resulting from occupational activity, or insurance to provide any of the foregoing, for unemployment benefits, life insurance, disability and sickness insurance, or accident insurance, for vacation and holiday pay, for defraying costs of apprenticeship or other similar programs, or for other bona fide fringe benefits, but only where the contractor or subcontractor is not required by other federal, state, or local law to provide any of the benefits; provided, that the obligation of a contractor or subcontractor to make payment in accordance with the prevailing wage determinations of the director of labor and training insofar as this chapter of this title and other acts incorporating this chapter of this title by reference are concerned may be discharged by the making of payments in cash, by the making of contributions of a type referred to in subsection (b)(2), or by the assumption of an enforceable commitment to bear the costs of a plan or program of a type referred to in this subdivision, or any combination thereof, where the aggregate of any payments, contributions, and costs is not less than the rate of pay described in subsection (b)(1) plus the amount referred to in subsection (b)(2).
 - (c) The term "employees", as used in this section, shall include employees of contractors or subcontractors performing jobs on various types of public works including mechanics, apprentices, teamsters, chauffeurs, and laborers engaged in the transportation of gravel or fill to the site of public works, the removal and/or delivery of gravel or fill or ready-mix concrete, sand, bituminous stone, or asphalt flowable fill from the site of public works, or the transportation or removal of gravel or fill from one location to another on the site of public works, and the employment of the employees shall be subject to the provisions of subsections (a) and (b).
 - (d) The terms "public agency" and "quasi-public agency" shall include, but not be limited to, the Rhode Island industrial recreational building authority, the Rhode Island economic development corporation, the Rhode Island airport corporation, the Rhode Island industrial facilities corporation, the Rhode Island refunding bond authority, the Rhode Island housing and mortgage finance corporation, the Rhode Island resource recovery corporation, the Rhode Island public transit authority, the Rhode Island student loan authority, the water resources board corporate, the Rhode Island health and education building corporation, the Rhode Island higher education assistance authority, the Rhode Island turnpike and bridge authority, the Narragansett Bay water quality management district commission, Rhode Island telecommunications authority, the convention center authority, the board of governors for higher education, the board of regents for elementary and secondary education, the capital center commission, the housing resources commission, the Quonset Point-Davisville management corporation, the Rhode Island depositors economic protection corporation, the Rhode Island lottery commission, the Rhode Island

Compliance with Instructions to Bidders

These Instructions to Bidders contain terms and conditions that will govern the preparation and submission of a bid proposal and any contract awarded pursuant to this solicitation.

Bidders must comply with each and every requirement of these Instructions to Bidders. Any failure to comply with any requirement may result in the determination of a nonresponsive bid proposal and/or the rejection of the bid proposal.

Priority of Terms and Conditions

The terms and conditions in these Instructions to Bidders *supersede* any and all inconsistent or conflicting terms and conditions in any other provision of any other document in this solicitation or in the bid proposal and govern this solicitation, the bid proposal, and any contract awarded pursuant to this solicitation.

Offer to Contract

Bid proposals constitute an offer to contract with the State of Rhode Island through the Department of Administration Division of Purchases on the terms and conditions contained in the solicitation, the laws of the State of Rhode Island, including all procurement statutes and regulations (available at www.purchasing.ri.gov), and applicable federal and local law, all of which are incorporated into this solicitation and any contract awarded pursuant to this solicitation by this reference.

Addenda

Responses to questions from bidders, interpretations of plans and specifications, changes prior to the bid proposal submission deadline, approvals of any substitutions, and supplemental instructions and terms will be posted as addenda on the Division of Purchases website at www.purchasing.ri.gov, and all addenda become incorporated into this solicitation upon posting. Bidders are responsible for checking the website to determine the issuance of any addenda. Inspection

The public copy of each bid proposal will be posted on the Division of Purchases website. Bidders may redact in the public copy any trade secrets or commercial or financial information which is of a privileged or confidential nature pursuant to the Access to Public Records Act.

For Rhode Island Department of Transportation highway and bridge projects, in addition to the Quest Lite compatible electronic copy and one hard copy, the bidder must also include a duplicate original of the Quest Lite compatible electronic copy on a *read-only* CD-R media disk as the "public copy."

Contractors Registration

The bidder must have and maintain a valid certificate of registration issued by the Contractors' Registration Board throughout the term of the contract awarded pursuant to this solicitation and ensure that its subcontractors, unless exempt from registration, also obtain and maintain valid certificates of registration.

<u>Subcontractors</u>

The bidder must demonstrate that it is able to perform a substantial portion of the work using its own workforce. Any bidder that does not maintain a permanent workforce and/or proposes to perform a disproportionate amount of the work through one or more subcontractors will be considered unqualified. The successful bidder must establish to the satisfaction of the State Purchasing Agent the reliability and responsibility of any subcontractors proposed to perform any work pursuant to this solicitation.

Taxes

The State of Rhode Island is exempt from federal excise taxes and state and municipal sales and use taxes. The bidder shall not include such taxes in any prices in the bid proposal.

Bid Surety

Bidders must furnish, with their bid proposals, either a bid bond from a surety licensed to conduct business in the State of Rhode Island or a certified check payable to the State of Rhode Island in the amount of five (5%) percent of the bid proposal. (Bidders for Rhode Island Department of Transportation highway and bridge projects must furnish, with their bid proposals, a bid bond from a surety licensed to conduct business in the State of Rhode Island. Certified checks are not permitted for these projects.) An attorney-in-fact who executes a bond on behalf of the surety must provide a certified current copy of the power of attorney. A successful-bidder-who-fails to submit the additional documentation required by the tentative letter of award and/or fails to commence and pursue the work in accordance with the contract awarded pursuant to this solicitation may forfeit, at the discretion of the State Purchasing Agent, the full amount of the bid surety as liquidated damages. The State will retain the bid surety of all bidders until the earliest of: (i) the issuance of the Purchase Order; (ii) the 61st day following the bid proposal submission deadline; or (iii) the rejection of all bid proposals.

Divestiture of Investments in Iran Requirement

No bidder engaged in investment activities in Iran as described in R.I. Gen. Laws § 37-2.5-2(b) may submit a bid proposal to, or renew a contract with, the Division of Purchases. Each bidder submitting a bid proposal or entering into a renewal of a contract is required to certify that the bidder does not appear on the list maintained by the General Treasurer pursuant to R.I. Gen. Laws § 37-2.5-3.

Domestic Steel

Any steel products required by the plans and specifications in this solicitation must be formed, extruded, forged, cast, fabricated, or otherwise processed from steel made in the United States.

<u>Withdrawal</u>

A bidder may withdraw its bid proposal at any time prior to the bid proposal submission deadline. Bid proposals are irrevocable for a period of 60 days following the bid proposal submission deadline.

Reservation of Rights

The Division of Purchases reserves the right, at any time, for any reason, in its sole discretion, to: (i) revoke, suspend, or terminate this solicitation; (ii) accept or reject any and all bid proposals, in whole or in part; (iii) waive any technical defects, irregularities, or omissions in any bid proposals; and/or (iv) terminate any contract awarded pursuant to this solicitation, with or without cause.

Award

The State Purchasing Agent, in his or her sole discretion, will award the contract pursuant to this solicitation to the responsive and responsible bidder who submits the lowest responsive and responsible bid proposal. The State Purchasing Agent may determine, in his or her sole discretion, the low bid proposal on the basis of the amount of the Base Bid Price plus the alternates selected in accordance with the Request for Quote. The successful bidder will receive a tentative letter of award from the Division of Purchases with instructions for the bidder to submit further documentation. A binding contract, to the extent of available funds, between the State of Rhode Island and the successful bidder will be formed by the issuance, and only by the issuance, of a Purchase Order from the Division of Purchases. The successful bidder shall be authorized to commence work only upon the issuance of the Purchase Order and, in addition, an authorization from the user agency. The issuance of the Purchase Order and the continuation of any contract awarded pursuant to this solicitation is contingent upon the availability of funds.

Prevailing Wages

The successful bidder and its subcontractors must pay their workers at the applicable prevailing wage rates (adjusted every July 1) for the various trades on a weekly basis, pay their workers one and one-half times the applicable prevailing wage rates for each hour worked in excess of 8 hours in any one day or 40 hours in any one week, and submit certified weekly payroll forms on a monthly basis to the user agency. Prevailing wage posters and rate schedules, available at the Rhode Island Department of Labor and Training website at www.dlt.ri.gov, must be posted at the project site.

Occupational Safety

The successful bidder must ensure (if the total contract price is at least \$100,000) that all employees at the project site possess a card issued by the United States Department of Labor certifying successful completion of an OSHA ten (10) hour construction safety program.

Hazardous Substances

The successful bidder must submit a chemical identification list to the Rhode Island Department of Labor and Training upon receipt of a Purchase Order from the Division of Purchases prior to performance of the contract awarded pursuant to this solicitation and make available to all employees a list of any hazardous substances that may present a risk of exposure.

Substitutions

Any proposal in response to a request for substitutions in the solicitation must include the detailed information necessary for a comprehensive evaluation, including (without limitation) the name of the material or equipment of the proposed substitution and a complete description of the proposed substitution, with drawings and performance and test data. Products specified in this solicitation establish a standard of quality, performance, dimension, function, and appearance. Proposed substitutions must meet the standard and will not be considered without the prior written approval of the Division of Purchases. All substitution approvals will be posted, as addenda to the solicitation on the Division of Purchases website.

Licenses

The successful bidder and anyone performing any services on the contract awarded pursuant to this solicitation must possess all of the licenses required by any federal, state, or local law to perform such work.

Insurance

The successful bidder must submit a certificate of insurance that references the solicitation number and names the State of Rhode Island as "certificate holder" and as "additional insured" upon the issuance of the tentative letter of award, on an annual basis during the term of the contract awarded pursuant to this solicitation, and from time to time upon request. The State Purchasing Agent reserves the right to accept alternate forms and plans of insurance and/or to require additional or more extensive coverage.

Minority Business Enterprises

The Division of Purchases reserves the right to give additional consideration to bid proposals submitted by minority/women business enterprises certified by the Division of Purchases, Minority Business Office ("MBEs") provided that any such bid proposal is fully responsive to the terms and conditions of this solicitation, and the bid price is determined, in the discretion of the Division of Purchases, to be within a competitive range.

Any bidder who does not intend to perform all of the work with its own forces shall recruit and engage MBEs to perform at least 10% of the dollar value of the contract awarded pursuant to this solicitation. To reach that goal, the bidder may allocate up to 60% of its costs for materials and supplies obtained from MBE dealers or 100% of its costs for materials and supplies obtained from MBE manufacturers.

The successful bidder must submit a plan to meet this requirement for approval by the Division of Purchases, Minority Business Enterprise Compliance Office within the 21-day period following the tentative letter of award, identifying all MBEs, and must also demonstrate its good faith best efforts to meet these MBE goals. Equal Opportunity

Foreign Corporations

Campaign Finance

The successful bidder who has contributed, within the 24 months preceding the contract award, an aggregate amount of more than \$250.00 within a calendar year to any Rhode Island general officer, candidate for general office, any member of the general assembly, or any Rhode Island political party, must file a "Vendor Affidavit" with the State of Rhode Island Board of Elections. Binding Contract

A binding contract between the State of Rhode Island and the successful bidder will be formed by the issuance of a Purchase Order from the Division of Purchases, and only by the issuance of a Purchase Order, and only to the extent of available funds. The binding contract will incorporate and be subject to the terms and conditions of the solicitation, including the Invitation to Bid, the Instructions to Bidders, the Bid Preparation Checklist, the Request for Quote, the Bidder Certification Cover Form, the Agreement (if applicable to this solicitation), and also the Purchase Order. The successful bidder shall be authorized to commence work only upon the issuance of the Purchase Order and, in addition, an authorization from the user agency.

Compliance with Terms of Contract

Failure of the successful bidder to comply with the terms and conditions of any contract awarded pursuant to this solicitation may result in nonpayment, suspension or termination of the contract, suspension or debarment of the bidder, or any other necessary or appropriate remedy.
