- Note the requirements for working in Correctional facilities.
- This is a prevailing wage project. Note the certification within the bid package that acknowledges you are aware of your obligations as they pertain to prevailing wage.
- Included is a bid preparation check list to help you. It is not a substitute for a thorough review of the instructions to bidders.
- We are also asking that you submit a new state w-9. The state form is different from the federal form. It is attached to the bid package.

Questions submitted on line:

Q. In regard to Solicitation 7598847 titled Security Camera Installation/Upgrades For The DOC – will new SCADA software be purchased? Or will work be implemented into an existing system?

A. The Dix Building will incorporate the Genetec Software for camera monitoring and access control. The Genetec platform is utilized in all the DOC facilities. The Probation & Parole Buildings will utilize a local software that will be monitored at each specific building.

Q. Are there any drawings to be released for this bid?

A. No

Q. We reached out to MTI and identified there is only 1 certified dealer in New England. We cannot comply with the bid requirement for this product. Is it acceptable to exclude the MTI scope of work from our response?

A. This part of the bid specifications is removed:

- vi. A certificate or letter from MTI stating that the bidder is an authorized and certified dealer of MTI products and systems. The bidder must be manufactured certified a minimum of five (5) years prior to the bid date. Failure to provide this information will result in bid rejection.
- vii. The bidder shall provide references from three (3) MTI projects similar in size and scope. Reference material shall include:
 - 1. Project name.
 - 2. End user name.
 - 3. End user address.
 - 4. End user phone number.
 - 5. End user email address.
