- There are two (2) architects involved in this project. Any questions during the project will be 6. directed to the National Guard Project manager who will in turn direct the question(s) to the appropriate architect.
- The old HVAC system is to remain in place until the new system is operational. The new system 7. needs to be a non-proprietary system.
- There are different drop ceiling heights throughout the building(s). The new drop ceiling heights will match the existing.
- 9. Company vehicles will be allowed through the gates and can be parked along the fence line in the back. Vehicles will not be inspected. Vendor may locate a dumpster along the fence line in back.
- It will be imperative that the vendor work closely with the project manager on scheduling. 10.
- 11. Vendor may be subject to an additional security check. This will be at vendor cost.
