This first part is a duplication of what is in the original bid posting:

- This is a mandatory pre-bid conference. Only those vendors on the sign in sheet may submit a bid.
- Dishwashers will be delivered and installed by the awarded vendor. Ovens will be delivered only to the location where they will be connected by others.
- The agency will be responsible for removal/disposal of the old equipment.
- This equipment is currently in use in all ACI facilities and due to staff transfer on a daily basis, familiarity with the equipment is imperative. Therefore, this is a NO SUBSTITUTION bid.
- Vendors must bid all lines.
- Prices include delivery and installation. All vendor employees entering Department of Corrections property must pass a BCI check. This is done by the Department of Corrections

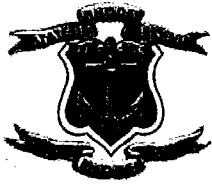
