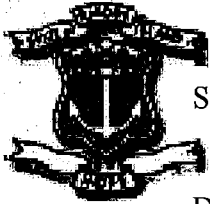

TERMS AND CONDITIONS FOR THIS BID

INSURANCE REQUIREMENTS
