CLARIFICATION AND REQUIREMENTS – INTEGRATED FIRE ALARM AND MASS NOTIFICATION SYSTEM

Scope of Work

A new integrated fire alarm/mass notification system shall be provided and installed as indicated on the design documents and the mass notification system shall be as follows:

- 1) A command center in each of three buildings Nos. 1, 2 and 3.
- 2) Command centers to include the fire alarm control panel with mass notification including voice evacuation to create and distribute live (microphone or handset) or pre-recorded messages.
- 3) Mass notification to be capable of initiation from any of the three buildings.
- 4) Mass notifications to be to all three buildings simultaneously.
- 5) Provide all interconnecting wiring between buildings as required to make the system fully functional as indicated herein.
- 6) Amber alert strobes and notification speakers shall be provided in the proximity of each fire alarm strobe in each building.
- 7) Provide additional recessed speakers throughout each building sufficient to ensure voice intelligibility throughout during notifications.
- 8) Manual alert activation stations shall be in the proximity of the main alarm panel and each alarm subpanel in each building (for a total of 3).
- 9) All equipment selections shall be submitted for review and approval.

Sequence of Operations

- 1) The manual alert activation is initiated.
- 2) The amber alert strobes shall be activated in all locations.
- 3) Voice communication shall be enabled at each command center either live or pre-recorded.
- 4) Each panel (3) shall have provisions for alert deactivation.
