1. When can the low-bid contractor assume receiving Notice To Proceed

A. Bid closes on 7/3/2020. Tentative letter of award probably sent sometime the week of 7/6/2020 at which point the vendor will be given 21 days to send in all documentation required. Notice to Proceed will be dependent on promptness of vendor response to award letter, MBE approval and completion of agreement between vendor and DEM.

2. Please confirm no driving shoes are required for the Greenheart dolphin piles or SYP dock piles

- 4. At Docks TT & UU, please confirm who is responsible for de-energizing the dock dock electrical system to allow the contractor to safely remove & re-install the power pedestals when replacing the main pier decking at each dock.
  - A. Owner shall be responsible for de-energizing the dock electrical system.
- 5. At Docks TT & UU, please confirm if the contractor will have unobstructed access to complete the decking removal & reinstallation. Please confirm how much access is required to be maintained down the center pier – i.e. does decking removed have to be reinstalled that same day

A. DEM will make every effort to provide contractor with unobstructed access to the Work. All decking removed must be replaced with new decking the same day.

- 6. Please confirm the extent of the floating dock sections at Dock SS that are to be salvaged, including the quantity of salvaged dock sections, what state the salvaged dock sections are to be given to the owner, and where the owner is to take possession of the salvaged dock sections.
- A. 6 complete floats to be retained for owner. Floats should be delivered to the RIDEM Coastal office parking lot.
- 7. Please confirm the details of the cleats require for the new dock SS system size, finish, quantity, and method of attachment to the dock structure
- A. Furnish and install six (6) twelve inch (12") galvanized cleats with internal Salt angle brackets and galvanized bolts and nuts on each finger pier section, three (3) on each side equally spaced, for a total of thirty-six (36) for the finger piers. Furnish and install eight (8) twelve inch (12") galvanized cleats with internal angle brackets and galvanized bolts and nuts on each main pier section, four (4) on each side equally spaced, for a total of forty-eight (48) for the main piers.
- 8. Please confirm the water spigot detailing of the new dock is to match the existing dock, with a 4x4 post, PEX tubing up the back of the post, and spigot through the 4x4. Please confirm the number of spigots required.
  - A. All spigots shall be replaced in kind and quantity.
- 9. Please confirm the sizing of the gangway rub pad required to protect the surface of the new dock section from the gangway coming from the fixed portion of dock SS
  - A. Rub pad shall be 6' x 4'.
- grigit 10. Please confirm the dolphin pile-to-pile bolting scheme, as the verbiage of "use (10) 30" x 1" bolts (2 per pile)" is not adding up with the 4 batter piles & 1 king pile.
- A. Bolting scheme is correct as shown. Two (2) bolts per pile, five (5) piles equals ten (10) bolts total
- 11. Please confirm if any on-site secure area will be made available for contractor to store materials (decking boards, piles, new dock sections)
- A. Owner shall work with the contractor to determine a secure area for material 医直接性 storage.
- 12. One of our float suppliers indicated that they cannot provide 1.5 CCA treatments on 1x6 decking. What would be acceptable – 5/4x6 lpe, ACQ, other?

- A. 6 complete floats to be retained for owner. Floats should be delivered to the delivered? 30% RIDEM Coastal office parking lot.
- 14. AWPA (American Woodworkers Preservative Association) prohibits the use of CCA treated lumber on decking. Can we supply the dock with 0.31 mCA or use a  $5/4 \times 6$  tropical hardwood?

A. ACQ is acceptable.

- 15. Please confirm the number of pile guides on the system.
  - A. There are seven (7) hoop and roller pile quides.
- 16. What is the design deadload freeboard?
  - A. A freeboard of no less than 18" should be used in design of floats.
- delive 17. Since public opening will not occur, can the bid opening time be changed to 2 pm? Allowing contractors to Fed-Ex bids.
- A. FEDEX delivers regularly to this building in the morning. It is the vendor's responsibility to make sure the bid arrives in time. Late bids are not accepted.
  - 18. Is a building permit required? Are fees waived if yes?

A. Building permit is not required

- 19. Removal of the float pontoons, hardware and pile hoops were discussed for reuse by the owner. Can a quantity of items wanted for reuse be provided for bidding purposes?
- A. 6 complete floats to be retained for owner. Floats should be delivered to the RIDEM Coastal office parking lot.
- 20. Please provide current Rhode Island prevailing wages. The link provided did not allow for viewing of the state prevailing wages.
  - A. This is the link to the Department of Labor and Training's website.
- 21. Will a pile driving barge of 35' x 120' size be allowed during boating season for Allow removal and redriving of the piles in the work areas of SS / TT/ SS?
- A. There is no piling work called out on SS dock. However, a 120' barge can work adjacent to UU, TT docks for fender piling driving and adjacent to G & H docks for dolphin cluster driving.
- 22. Can 6" screws be used in lieu of 6" spiral galvanized nails? No, 6" galvanized nails are to be used.

23. Are any of the dolphin piles also connected to the piers at G and H?
