In your submittal you will have your technical proposal and in a separate envelope within your bid submittal will be the cost proposal. **DO NOT INCLUDE THE COST PROPOSAL WITH YOUR TECHNICAL PROPOSAL.**

**BID OPENING PROCEDURE:** No one is allowed to attend the bid opening in person. Bid opening will be through the ZOOM app. Instructions how to access the opening will be posted in an addendum. There will be no public opening other than to read the names of those vendors submitting proposals, which is the normal procedure for RFP'S. Bids can be hand delivered if you choose. Keep in mind you will be required to wear a mask and undergo health questioning prior to being allowed to drop off your bid.
