1. The Press Release says The full RFP, along with a Proposal Offer Form, is available at <a href="https://www.ridop.ri.gov/">https://www.ridop.ri.gov/</a> I can't find it there. I realize there is a link to the Zip file in the press release, and I see it there, but I can't find it on <a href="https://www.ridop.ri.gov">www.ridop.ri.gov</a> in any of the options shown there. Not by RFP number or a description.

Answer: Click on bidding opportunities. All solicitations and then the solicitation number 7611830 to locate the bid documents.

2. The Solicitation Information states to submit a proposal "vendors must register on-line at the State Purchasing Website at <a href="www.purchasing.ri.gov">www.purchasing.ri.gov</a> and download a Bidder Certification Cover form which must accompany each offer." Is the Cover Form the one to fill out regarding the specific RFP? The Proposal Offer Form which I would think was to be sent with the Bidder Certification Cover form is pretty generic, and there is no place to differentiate which of the three properties in the RFP one is bidding on.

Answer: The was an error. <u>Vendor registration and the Bidder Certification Cover form are not required.</u> The only document required to submit an offer is the "Proposal Offer Form," which is in Appendix C of the RFP.

3. Is the form only to be mailed in as I see no directions for faxing or emailing the form? The mail has been terribly slow and this does not provide a lot of time, so I want to be sure people move fast enough.

Answer: We cannot accept email or fax. Must be hand delivered or use postal type service.

4. I am a single person, not a business and I'm looking to partner with the state to use regenerative farming practices, do I need to be an incorporated business or have a business license to submit a proposal?

Answer: Individual can submit. This purpose of this solicitation is not to partner with the state to use regenerative farming practices. Some regenerative practices may be allowed, provided all conditions of the bid proposal and subsequent lease are met. Please note that livestock grazing, which is a common practice in regenerative farming, will not be allowed.

5. Can you give me an idea of what the ideal candidate looks like for this type of project? Is the state looking for large farming entities or are they open to people like myself?

Answer: An ideal candidate is a person or entity who has experience with farming and is able to meet the conditions set forth in the RFP.

6. Is my proposal supposed to include my "bid" for the land lease?

Answer: Yes, please make sure to read the solicitation on how to submit and submit your bid using the Proposal Offer Form.

7. Would the state delay the opening to allow more time gather information?

Yes, the State has extended the bid opening from February 24, 2021 to March 1, 2021 to allow proposers more time to gather information. The time the bid is due remains at 10:00 a.m.
