



SOLICITATION #7651813 CLARIFICATIONS:

- Decommissioning Wickford and Hope Valley Barracks: Provide design services to decommission the existing communication towers at both sites. The Scope of Work shall include disconnecting all communications equipment and dismantling the existing metal communications towers at both sites. Any remaining utility connections to the communications tower shall be made safe.
- 2. **Decommissioning Wickford and Hope Valley Barracks:** Assume removal and disposal of all existing furniture. Computer and electronic equipment of any value shall be removed by RISP.
- 3. **Decommissioning Wickford and Hope Valley Barracks and Installation at New Southern Barracks:** Provide design services to re-frame and/or re-mount RISP memorabilia for installation in new Southern Barracks. Assume salvaging and collecting any RI State Police memorabilia from both barracks for installation in new Southern Barracks.
- 4. **Decommissioning Wickford and Hope Valley Barracks:** Provide design services to disconnect and salvage the existing generators at both Wickford and Hope Valley Barracks, for turnover to the State of Rhode Island.
- 5. **Decommissioning Wickford and Hope Valley Barracks:** All RISP files shall be removed by the RISP in advance of the decommissioning activities.
- 6. **Decommissioning Wickford Barracks:** Provide design services to resolve the water infiltration issue in the basement. Two new sump pumps and a new perimeter drainage system were recently installed as part of facilities maintenance. Despite the improvements, the water problem persists. The issue needs to be resolved as part of decommissioning, so that when the building is vacated and unoccupied, there is not an unmonitored water problem. There are no plans to demolish either barracks.
- 7. **Decommissioning Wickford Barracks and Installation at New Southern Barracks:** Provide design services for a new **optional** K-9 (canine) training course at the new Southern Barracks. The existing K-9 training course equipment at the Wickford Barracks shall be salvaged and incorporated into the new K-9 training area at the new Southern Barracks. The K-9 training course shall be an add-alternate in the future construction package. Planning, design, cost estimates and bidding are required as part of the Scope of Work.
